WSC ADVISORY #2021-035 AMENDED WORKER RECORD UPDATES

IMMEDIATE ACTION REQUIRED

EFFECTIVE DATE: OCTOBER 6, 2021, AMENDMENT NOVEMBER 3, 2021

It is the Qualified Organization's responsibility to keep accurate business contact information for Waiver Support Coordinators (WSCs) and CDC+ Consultants in APD iConnect. This information is found on the Worker Record. The record is the main source of information for each Waiver Support Coordinator and CDC+ Consultant. The Agency for Persons with Disabilities (APD) uses this information to communicate with all WSCs and CDC+ Consultants in a timely manner and shares it with clients who are in the process of choosing a WSC or CDC+ Consultant or needing their contact information.

Qualified Organizations should ensure that Worker Records are updated for all WSCs and CDC+ Consultants by using the **Service Provider role**. To update the Worker Record, review the information for accuracy, including the business address, business phone number, and business email, plus add the designated counties and languages spoken. This information must be unique to the WSC or CDC+ Consultant. Please do not enter QO information on the Worker Record. Failure to maintain accurate WSC or CDC+ Consultant contact information on the Worker Record may prevent a WSC or CDC+ Consultant from appearing on the list of options when a client is selecting a WSC or CDC+ Consultant.

Amendment – As of November 3, 2021, QO's have the capability to add and edit Languages to Worker Records.

How to Update a Worker Record

QO Owners will log into APD iConnect using the **Service Provider** role. Click the Providers chapter. In the Quick Search field at the top of the page, and search for your Provider Name. Please select your QO provider record.

Step 1: Select the Workers tab. Locate the Worker's Record and click to open it. On the Worker Record, update all fields related to the WSC's or CDC+ Consultant's business information. Including:

- A. Business Address the address used for business mail, use the search features to select the address fields, do not type out the address
- B. Business Phone the primary number to contact the WSC or CDC+ Consultant
- C. Business Email a general inbox for the whole QO is not acceptable
- D. Designated Zip this field will auto fill once you select Designated Counties
- E. Designated Counties select all the counties in which the WSC or CDC+ Consultant serves clients

Then click File > Save and navigate to the Languages tab on the left side of the screen.
